### **Consultant to conduct SRHR policy and legislation review and analysis**

#### **Background**

Regional Network of the Children and Young People Trust (RNCYPT), is a child and youth focused organization that has been working in Zimbabwe since 2012. RNCYPT works to transform how societies treats children and young people; through ensuring that children and young people are active citizens who demand access to all their rights, hold duty bearers to account and mobilize communities for the respect, promotion and fulfilment of their rights. RNCYPT believes in a holistic approach to the rights of children and young people, including empowering them as actors for justice and advocates of their own human rights.

RNCYPT is currently implementing a two year project titled Her Voice 4 Change; supported by AmplifyChange. The project's ultimate result is improved access to SRHR resources, services and information for marginalised Girls and Young Women (15-24years). In order to inform advocacy work for law and policy reform on SRHR, RNCYPT is looking for an experienced and competent consultant to conduct SRHR policy review and analysis.

#### **Objectives**

The overall objective of this consultancy is to conduct a review of policy and legislation on SRHR. This includes SRHR strategies, plans and programmes at national and local level.

#### **Scope of Work**

The scope of work for the Consultant will include but not limited to:

- Identifying SRHR policies and laws in Zimbabwe.
- Reviewing and analysing SRHR policies and laws in order to identify gaps in realising SRHR of Girls and Young Women.
- Come up with comprehensive recommendations for SRHR legislative reform and amendment informed by the analysis.
- Finalize the policy analysis and submit to RNCYPT.

#### **Deliverables**

- Review document of the SRHR policies and legislation.
- A detailed report that describes the SRHR policy and legislative gaps and areas for advocacy

#### **Time Span**

This assignment is expected to be carried out within a period of 10 days and a final report to be submitted to RNCYPT within 14 days.

#### **Institutional Arrangements**

The Consultant will report directly to the Executive Director. RNCYPT will provide relevant support to the consultant upon request.

## Expertise

### a) Academic Qualifications

At least a master's degree in Public Health, Public Policy, Social Science or equivalent.

### b) Experience, Skills and Competences

- At least 5 work experience in Social Accountability and Policy Analysis;
- At least 5 years' research experience on issues particularly SRHR, Gender and Health in general;
- Demonstrable experience in documentation, writing and content development in Social Accountability, Policy, SRHR, Gender and/or Health (including samples authored by the consultant of reports and/or analytical pieces).
